**MAKING AN APPROPRIATION TO EXPAND AND ENHANCE ECONOMIC

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:**

**Section 1. APPROPRIATION. --**

**A. Five hundred thousand dollars (\$500,000) is  
appropriated from the general fund to the board of regents of  
New Mexico state university for expenditure in fiscal year  
1999 to expand and enhance economic survival programs by the  
sustainable agriculture science center in Alcalde. The  
appropriation shall be distributed in the following amounts to  
the following entities:**

**(1) four hundred four thousand seven hundred  
eighty-five dollars (\$404,785) to the cooperative extension**
