BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Three hundred thousand  
dollars (\$300,000) is appropriated from the general fund to  
the department of environment for expenditure in fiscal years  
1999 and 2000 for the purpose of initiating the New Mexico  
rivers information system and conducting the rivers inventory  
and assessment. Any unexpended or unencumbered balance  
remaining at the end of fiscal year 2000 shall revert to the  
general fund.
