AN ACT

MAKING AN APPROPRIATION TO PROVIDE FOR ECONOMIC DEVELOPMENT  
INITIATIVES FOR ASSISTANCE IN TRAINING WOMEN ENTERING THE WORK  
FORCE AND TO START OR EXPAND WOMEN-OWNED BUSINESSES IN  
NORTHERN NEW MEXICO; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One million five hundred  
thousand dollars (\$1,500,000) is appropriated from the general  
fund to the economic development department for expenditure in  
fiscal years 1999 through 2001 for the purpose of contracting  
for training and services to provide for economic development  
initiatives in northern New Mexico and for assistance to start  
or expand women-owned businesses and to prepare women  
currently receiving public assistance to enter the work force.  
Any unexpended or unencumbered balance remaining at the end of

1 fiscal year 2001 shall revert to the general fund.

2 Section 2. EMERGENCY.--It is necessary for the public
