AN ACT

MAKING AN APPROPRIATION FOR A YOUTH-ORIENTED PROGRAM THAT
ACTIVELY ENGAGES "AT-RISK" AFRICAN AMERICAN YOUTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Five hundred thousand five
hundred thirty dollars (\$500,530) is appropriated from the
general fund to the state department of public education for
expenditure in fiscal year 1999 for the purpose of funding a
youth-oriented program that actively engages "at-risk" African
American youth and their families in activities that generate
self-empowerment and self-development. Any unexpended or
unencumbered balance remaining at the end of fiscal year 1999
shall revert to the general fund.
