AN ACT

RELATING TO CAPITAL EXPENDITURES; MAKING AN APPROPRIATION TO THE STATE HIGHWAY AND TRANSPORTATION DEPARTMENT FOR A CRITICAL EMERGENCY STREET LIGHT AT LA CUEVA HIGH SCHOOL; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --One hundred thousand dollars (\$100,000) is appropriated from the general fund to the state highway and transportation department for expenditure in fiscal years 1998 and 1999 for the installation of a critical emergency street light in front of La Cueva high school on Alameda at Wyoming in Albuquerque in Bernalillo county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1999 shall revert to the general fund.

Section 2. EMERGENCY. --It is necessary for the public
