AN ACT

RELATING TO JUDGES; PROVIDING FOR TWO ADDITIONAL MAGISTRATE  
JUDGES IN DONA ANA MAGISTRATE DISTRICT; PROVIDING FOR  
APPOINTMENT AND ELECTION; AMENDING A SECTION OF THE NMSA 1978;  
MAKING AN APPROPRIATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 35-1-10 NMSA 1978 (being Laws 1968,  
Chapter 62, Section 12, as amended) is amended to read:

"35-1-10. MAGISTRATE COURT--DONA ANA DISTRICT. --There  
shall be [~~three~~] five magistrates in Dona Ana magistrate  
district, with divisions 1, 2 and 3 operating as a single  
court in Las Cruces. The magistrates in divisions 1, 2 and 3  
shall rotate riding circuit to [~~Anthony and~~] Hatch on a  
regularly scheduled basis. The magistrates in divisions 4 and  
5 shall operate as a single court in Anthony. "
