AN ACT

RELATING TO TAXATION; EXTENDING THE EFFECTIVE DATE OF CERTAIN PROVISIONS OF THE INVESTMENT CREDIT ACT RELATING TO THE VALUE OF QUALIFIED EQUIPMENT AND EMPLOYMENT REQUIREMENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

"Section 10. EFFECTIVE DATE.--

A. The effective date of the provisions of Sections 1, 2, 4, 5, 7 and 9 of [~~this act~~] Laws 1990, Chapter 3 is January 1, 1991.

B. The effective date of the provisions of Sections 6 and 8 of [~~this act~~] Laws 1990, Chapter 3 is January 1, [~~2000~~] 2004."
