RELATING TO EMERGENCY CARE; CLARIFYING THE DEFINITION OF
EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 24-10-4 NMSA 1978 (being Laws 1963,
Chapter 59, Section 2) is amended to read:

"24-10-4. EMERGENCY DEFINED. -- As used in ~~[this act]~~
Sections 24-10-3 and 24-10-4 NMSA 1978, "emergency" means an
unexpected occurrence ~~[involving injury or illness to persons,
including motor vehicle accidents and collisions, disasters
and other accidents and events of similar nature]~~ of injury or
illness occurring in public or private places to a person that
results from:

A. motor vehicle accidents and collisions;

B. acts of God;
