AN ACT

RELATING TO SCHOOL BUS ROUTES; PROVIDING FOR GREATER LOCAL
SCHOOL DISTRICT CONTROL OF BUS ROUTES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 22-16-4 NMSA 1978 (being Laws 1967,
Chapter 16, Section 222, as amended) is amended to read:

"22-16-4. SCHOOL BUS ROUTES--LIMITATIONS--EXCEPTIONS--
MINIMUM REQUIREMENTS.--

A. Bus routes shall be established by the local
school district.

B. Except for students in grades kindergarten
through six, and as provided in Subsections C and D of this
section, no school bus route shall be maintained for distances
less than:

~~[(1) one mile one way for students in grades~~
