AN ACT

MAKING AN APPROPRIATION FOR SCHOOL-BASED ARTS EDUCATION PILOT PROGRAMS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Two million dollars (\$2,000,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal years 2000 and 2001 for the purpose of supporting the development, implementation and evaluation of school-based performing and visual arts education programs in elementary schools. The appropriation shall be distributed by the state department of public education to local school districts for up to twenty school-based programs. Any unexpended or unencumbered balance remaining at the end of fiscal year 2001 shall revert to the general fund.
