"[NEW MATERIAL] WORK PROGRAM - PUBLIC SCHOOLS. -- The
department and the state department of public education shall
establish a work program for participants to engage in a work
activity pursuant to Subsection A of Section 27-2B-5 NMSA 1978
at public schools. "
