### A JOINT RESOLUTION

PROPOSING THE TRANSFER OF THE PROPERTY WHERE LAS CUMBRES LEARNING CENTER IS LOCATED TO THE COUNTY OF RIO ARRIBA.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

WHEREAS, Section 13-6-3 NMSA 1978 requires ratification and approval of any sale, trade or lease of property for a period exceeding twenty-five years in duration or of a value of one hundred thousand dollars (\$100,000) or more; and

WHEREAS, Rio Arriba county requests that the land and improvements on the land where Las Cumbres learning center is located be transferred to that county for a period of time in excess of twenty-five years; and

WHEREAS, the property where Las Cumbres learning center is located is 1.040 acres more or less at Hunter and Espinosa streets in Espanola in Rio Arriba county, New Mexico and is .125455.2

WHEREAS, the property is further described as:

"beginning at a point for the southeasterly corner of the above said tract, said point bears North 89 degrees 45 minutes 36 seconds West a distance of 23.86 feet from A.P.3 of Comp. 54, P.C. 57, P1 of the above said Santa Clara Pueblo Grant (marked with a U.S.G.L.O. brass cap); thence North 89 degrees 39 minutes 57 seconds West from said point of beginning a distance of 149.24 feet; thence North 89 degrees 40 minutes West a distance of 37.74 feet; thence continuing North 89 degrees 40 minutes West a distance of 45.01 feet; thence continuing North 89 degrees 40 minutes West a distance of 58.05 feet; thence North 03 degrees 57 minutes East a distance of 159.32 feet; thence South 89 degrees 40 minutes East a distance of 48.0 feet; thence South 89 degrees 39 minutes 42 seconds East a distance of 232.0 feet; thence South 00 degrees 20 minutes 18 seconds West a distance of 158.98 feet to the point and place of beginning."; and

WHEREAS, the real property is subject to a thirty-two foot road easement along the eastern boundary line of the tract shown on the "Plat of Survey of Las Cumbres Learning

Center" done by Arsenio J. Martinez N. M. L. S. No. 4254 on November 25, 1987;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the transfer to Rio Arriba county of Las Cumbres learning center land and improvements on that land in Espanola be ratified and approved pursuant to the provisions of Section 13-6-3 NMSA 1978; and

BE IT FURTHER RESOLVED that a copy of this resolution be transmitted to the secretary of general services and the county commission of Rio Arriba county.
