10 A JOINT RESOLUTION
11 PROPOSING AN AMENDMENT TO ARTICLE 10, SECTION 1 OF THE
12 CONSTITUTION OF NEW MEXICO TO ALLOW FOR MIDTERM SALARY
13 INCREASES FOR COUNTY OFFICERS.
14

15 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

16 Section 1. It is proposed to amend Article 10, Section 1
17 of the constitution of New Mexico to read:

18 "The legislature shall at its first session classify the
19 counties and fix salaries for all county officers, which shall
20 also apply to those elected at the first election under this
21 constitution. And no county officer shall receive to his own
22 use any fees or emoluments other than the annual salary
23 provided by law, and all fees earned by any officer shall be
24 by him collected and paid into the treasury of the county.

25 Notwithstanding Article 4, Section 27 of the constitution of

1 New Mexico, a board of county commissioners may provide a
2 midterm salary increase for any elected county officer as
3 authorized by the legislature. "

4 Section 2. The amendment proposed by this resolution
5 shall be submitted to the people for their approval or
6 rejection at the next general election or at any special
7 election prior to that date which may be called for that
8 purpose.
