AN ACT

RELATING TO LICENSES; REQUIRING A SPACE ON LICENSE APPLICATION AND LICENSE RENEWAL FORMS FOR APPLICANTS TO STATE A DESIRE TO MAKE AN ANATOMICAL GIFT; REQUIRING THE MOTOR VEHICLE DIVISION OF THE TAXATION AND REVENUE DEPARTMENT TO MAINTAIN APPLICATIONS WITH THOSE COMPLETED STATEMENTS IN A STATEWIDE DONOR REGISTRY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. A new section of Chapter 17, Article 3 NMSA 1978 is enacted to read:

"[NEW MATERIAL] DONOR REGISTRY.--

A. In addition to other requirements established for a blank application furnished by the director of the department of game and fish pursuant to Section 17-3-5 NMSA 1978, the director shall include on each blank application a space to show whether the applicant is a donor as provided in

7 donor program personnel, immediately prior to or after a  
8 donor's death, may request verification of the donor's status  
9 from the division and may obtain a copy of the application from  
10 the division.

11 F. For the purposes of this section, "division"  
12 means the motor vehicle division of the taxation and revenue  
13 department."

14 SECTION 2. A new section of the Concealed Handgun Carry  
15 Act is enacted to read:

13 A. [~~Effective July 1, 2003~~] Applications for  
14 concealed handgun licenses shall be made readily available at  
15 locations designated by the department. Applications for  
16 concealed handgun licenses shall be completed, under penalty of  
17 perjury, on a form designed and provided by the department and  
18 shall include:

19 (1) the applicant's name, current address,  
20 date of birth, place of birth, social security number, height,  
21 weight, gender, hair color, eye color and driver's license  
22 number or other state-issued identification number;

23 (2) a statement that the applicant is aware  
24 of, understands and is in compliance with the requirements for  
25 licensure set forth in the Concealed Handgun Carry Act;

7 to the department may result in denial or revocation of a  
8 concealed handgun license and may subject the applicant to  
9 criminal prosecution for perjury as provided in Section 30-25-1  
10 NMSA 1978; and

11 (5) a space, as required by Section 2 of this  
12 2022 act, to show whether the applicant is a donor as provided  
13 in the Jonathan Spradling Revised Uniform Anatomical Gift Act.

14 B. The applicant shall submit to the department:

- 15 (1) a completed application form;  
16 (2) a nonrefundable application fee in an  
17 amount not to exceed one hundred dollars (\$100);  
18 (3) two full sets of fingerprints;  
19 (4) a certified copy of a certificate of  
20 completion for a firearms training course approved by the  
21 department;  
22 (5) two color photographs of the applicant;  
23 (6) a certified copy of a birth certificate or  
24 proof of United States citizenship, if the applicant was not  
25 born in the United States; and

2 C. A law enforcement agency may fingerprint an  
3 applicant and may charge a reasonable fee.

4 D. Upon receipt of the items listed in Subsection B  
5 of this section, the department shall make a reasonable effort  
6 to determine if an applicant is qualified to receive a  
7 concealed handgun license. The department shall conduct an  
8 appropriate check of available records and shall forward the  
9 applicant's fingerprints to the federal bureau of investigation  
10 for a national criminal background check. The department shall  
11 comply with the license-issuing requirements set forth in  
12 Section 29-19-7 NMSA 1978. However, the department shall  
13 suspend or revoke a license if the department receives  
14 information that would disqualify an applicant from receiving a  
15 concealed handgun license after the thirty-day time period has  
16 elapsed.

17 E. A state or local government agency shall comply  
18 with a request from the department pursuant to the Concealed  
19 Handgun Carry Act within thirty days of the request."
